FAQs

1. What if I do not know my address in the UK when completing this section of the application form?

The form will accept the University's address if you do not yet have the details of your accommodation in the UK. This is:

2. How can I satisfy the language requirement?

3. Who can I be financially sponsored by?

You can be sponsored by a government or an international scholarship agency or your parent/s. Parents however are not classed as official sponsors even though applicants are permitted to include their evidence as part of the application.

4. What does maintenance mean?

This is in reference to the amount of money you need for your fees and living costs.

5. How much money do I need?

The amount of money that you are required to show as held in your account, or that of your parent/s', if you are studying outside of London is:

• £9135 for 28 days. This is £1,015 per month for maintenance costs and you are required to show up to 9 months.

If you are studying in inner London is the amount of money is:

• £11,385 for 28 days. This is £1,265 per month for maintenance costs and you are required to show up to 9 months, without an established presence in the UK.

Please remember that any fees that are outstanding will also need to be added to this amount.

E.g. unpaid tuition fees + maintenance (for living costs) = the amount you will require.

6. Do I need an ATAS certificate?

7. What is the Immigration Health Surcharge?

This provides access to the NHS on the same terms as a permanent UK resident. It is £150 per year for a student and each dependant and £75 for part year. Non EEA nationals who apply to come to the UK to study for more than 6 months have to pay this.

The total surcharge amount is for the whole <u>period of leave</u> granted and will be payable upfront

8. Can my dependants apply?

Dependants include: your husband, wife or civil partner, your unmarried or same-sex partner and your child under 18 years old.

9. Can I bring my dependant child at a later date?

Both parents must be coming to the UK. The only acceptable options are:

- both parents are making an immigration application at the same time and in the same country as the child, or
- when the child makes their immigration application, one parent is physically present in the UK, and the other parent is making an immigration application at the same time and in the same country as the child, or
- both parents are already physically present in the UK

This requirement will not be met if both parents are physically outside the UK but only one of them is going to make an application at the same time as the child (even if the other parent already has immigration permission for the UK).
